# Preparing for **PEER REVIEW**

Peer Review has been described as the 'Gold Standard' of Quality Assessment and is now the central 'Quality' threshold for Legal Aid suppliers. The fully-fledged scheme is in operation and will impact upon both Preferred Supplier Status and the Carter Proposals.

With the first round of live reviews underway, it is only a matter of time before all firms serious about continuing with Legal Aid work will need to submit this to this fundamentally new form of assessment.

Despite all these implications, this development has largely passed the profession by.
